Hello,

With consents for both Norfolk Vanguard and Norfolk Boreas secured, we've hit the ground running in 2022, with an incredibly busy start to the year.

We are excited to introduce two new members of the team. Denise Hone and Will Sealey are based in the region and will be your project contacts going forward. You can read more about Denise and Will at the links below and you'll find their contact details on the project website.

Work is underway to get ready for onshore activities. Our expert archaeologists have been out and about in Norfolk, examining sites that may potentially provide insight into local history. This work ensures we are fully informed about the areas in which we're working and that any buried historic information is collected and protected. The next phase of engagement on community benefits has started, with the first of the localised meetings held in Necton in January. We are continuing to liaise with local elected representatives and Parish Councils to determine how and when we meet with the communities closest to the cable route. On Thursday 7th April, the Government launched its Energy Security Strategy, which makes clear the important contribution offshore wind is expected to make to improve our energy security, tackle climate change, and bring down the cost of energy for the UK consumer, while also supporting many thousands of jobs. Aligned with this ambition we are looking at optimizing the output of our projects, deploying the very latest offshore wind turbine technology.

Innovation, energy strategy & the Norfolk Zone

Technological development in the offshore wind industry continues apace.

In line with government policy, Vattenfall's Norfolk projects are seeking to use the very latest innovation and further reduce the cost to the consumer of the energy produced. To allow this, we will apply to make a "non-material change" to our Development Consent Orders for Norfolk Boreas and Norfolk Vanguard, namely, removal of the maximum export capacity limit and a reduction in the number of turbines out at sea. There is no change to the projects' onshore elements. Once submitted, the applications will be published on the Planning Inspectorate's project page and will be determined by the Secretary of State for Business, Energy and Industrial Strategy.
