## **About the scheme**

Vattenfall has comitted to a £3mn community benefit scheme that will run for the lifetime of the project. This means £150,000 will be invested annually into the local community.

### What's happened so far?

We commissioned support from one of Scotland's experts on renewable energy funding, Dr Claire Haggett, to work with us to ensure an independent approach was taken to develop the best possible community benefit scheme for the region.

Following a three month consultation, which generated a very good response from the area, we now have a clear picture of the kind of scheme that the community would like to see and we can now start planning the governance and practicalities to make sure the scheme becomes operational this year.

This booklet explains the key findings of this consultation and the resulting structure planned for the scheme.

### Who will benefit?

The boundary for the funding that was identified by some margin was the whole of Aberdeen City and Aberdeenshire, with a high level of support for the substation host community in Blackdog to have access to an annual ringfenced amount. "Arguably one of the greatest assets of community schemes is the ability to deliver projects that harness and strengthen social capital and, in turn, create stronger, more pro-active communities."

# How will your feedback be implemented?

### Structure:

- there will be two application processes one for small projects and one for large projects
- a ringfenced amount of £15,000 annually, 10% of the overall scheme, will be available to Blackdog for projects or activities that meet the criteria of the scheme
- to get the scheme off to a good start, a part time community development officer will be appointed, initially for two years, to offer support to communities to develop ideas and approaches to make the most of the funding and achieve maximum possible impact

### **High-level criteria:**

- ensure a legacy and lasting impact
- contribute to a climate smarter world with sustainability at its core
- invest in community facilities that are fit for the future and environmentally sustainable
- demonstrate clearly a benefit to the local community
- Match funding is encouraged but not required

### **Exclusions identified:**

- commercial businesses
- anything that ought to be delivered by statutory services
- individuals
- projects that do not take account of their environmental impact

### **Decision making**

The feedback was clear that there should be a decision making board/ panel making funding decisions. We will be inviting community champions to apply in the coming months and will be seeking people with a broad range of experiences, skills and expertise.

### **Next steps**

We will now begin the work of establishing the governance structures, legal framework and administration for the scheme, working with local groups and organisations, alongside the Aberdeen Renewable Energy Group.

### This will include:

- developing an appropriate legal framework
- developing an agreement between
  Vattenfall and the organisation/s who will operate the benefit scheme
- making sure we establish an accountable efficient, independent local and fair set up.

We will continue to undertake this process in consultation with you. We will be meeting with potential organisations in the coming months to see who can best help deliver the scheme to the community's set criteria.

Once this has been agreed, an application process will be developed and a community development officer will be appointed.
